Duck Brown Contracting was contracted to do the work, with the help of the Highway Department. There were approximately 43 employees impacted.

Negotiations is scheduled for tomorrow with the Sheriff's Deputies and Supervisors Units.

The Board of Elections has completely relocated to their new space in the Canton Human Services Building.

The Space Committee met today to discuss the immediate use of old jail, as well as the space in the Courthouse. The Courts are requesting space for new court room.

Vacancy Review Committee met and reviewed thirteen (13) vacancies.

A resolution regarding the Legislative Agenda for St. Lawrence County will be coming forward on an upcoming Finance Committee meeting agenda. Possible dates to travel to Albany to deliver the agenda are March 13-15.
