# ADOPTING PROPOSED LOCAL LAW A (NO. \_\_) FOR THE YEAR 2011, AMENDING LOCAL LAW NO. 1, FOR YEAR 2009, THE ST. LAWRENCE COUNTY ETHICS LAW, TO MAKE CHANGES TO THE ANNUAL STATEMENT OF FINANCIAL DISCLOSURE

WHEREAS, St. Lawrence County, in Local Law No. 1 of 2009, enacted a local Ethics Law and created a Board of Ethics, and

WHEREAS, the Board of Ethics has reviewed the Annual Statement of Financial Disclosure adopted as part of the Ethics Law and finds that certain changes to the Annual Statement of Financial Disclosure would clarify the wording and provide additional information necessary for the Ethics Board to determine compliance with the Ethics Law when called upon to do so, and

WHEREAS, a Public Hearing regarding this Local Law was held on January 24, 2011,

**BE IT ENACTED** by the Board of Legislators of St. Lawrence County as follows:

Section 1. St. Lawrence County hereby amends Local Law No. 1 of 2009 by deleting the entire Annual Statement of Financial Disclosure included in Article 24 of that Local Law and replacing it in its entirety with the following Annual Statement of Financial Disclosure:
