## PROPOSED LOCAL LAW NO. 2 FOR THE YEAR 1990

# VOLUNTEER AMBULANCE WORKERS' INSURANCE FOR INDEPENDENT RESCUE SQUADS

WHEREAS, the New York State Volunteer Ambulance Workers Benefit Law requires independent rescue squads to provide specific medical and lost time payments to their members, and

WHEREAS, independent rescue squads perform valuable and critical services to the citizens of the County of St. Lawrence, and

WHEREAS, various of the squads may find it economically advantageous to obtain certain of their coverages from the St. Lawrence County Self-Insured Workers' Compensation Plan,

NOW. THEREFORE, BE IT RESOLVED, that Local Law No. 1 of 1956 be and it is hereby amended to permit Independent rescue squads in St. Lawrence County to participate in the St. Lawrence County Self-Insured Workers' Compensation Plan effective January 1, 1991, with the following conditions prior to joining:

- An accurate roster and current medical examination reports must be provided to the St. Lawrence County Self-Insured Workers' Compensation Plan by each squad for all current or future members.
- Each squad shall provide their last three years accident and injury experience to the St. Lawrence County Self-Insured Workers' Compensation Plan.

- 3. Any squad that wishes to join the St. Lawrence County Self-Insured Workers' Compensation Plan must be sponsored by and a petition received from a local municipality. That municipality must have agreed to have that independent rescue squad's volunteer ambulance benefit experience added to its workers' compensation experience each year for rating purposes.
- 4. Each squad which joins the St. Lawrence County Self-Insured Workers' Compensation Plan shall become familiar with all facets of the Plan and shall in all ways participate in any reasonable requests for the Plan, including training, reporting, preparation of documents, both for the Plan and the Workers' Compensation Board, and shall otherwise cooperate with any reasonable request made to it by the Plan.

Except as stated above, all the conditions and policies as stated in Local Laws No. 1 of 1956 and No. 9 of 1977 shall remain in effect.

## INCREASING COUNTY CLERK'S PISTOL PERMIT RETENTION FEE FROM \$5.00 TO \$10.00

BE IT ENACTED by the Board of Legislators of the County of St. Lawrence as follows:

Section 1: A fee of \$10.00 is established as the County Clerk's portion of the Pistol Permit Application Fee within the County of St. Lawrence, resulting in a new pistol permit application fee of \$54.00, the State of New York's share being \$44.00, and the County of St. Lawrence's share being \$10.00.

<u>Section 2</u>: The fee is payable as a part of the pistol permit application fee to be charged effective October 1, 1990.
