PROPOSED LOCAL LAW NO. 14 FOR THE YEAR 1986

AUTHORIZING ST. LAWRENCE COUNTY TO BECOME A PARTICIPATING MEMBER OF THE CAPITAL DISTRICT REGIONAL OFF-TRACK BETTING CORPORATION

Be it enacted by the Board of Legislators of the County of St. Lawrence as follows:

- <u>Section 1</u>. This law shall be entitled "An act to provide for participation of St. Lawrence County in the Capital District Regional Off+Track Betting Corporation".
- Section 2. St. Lawrence County is hereby authorized to actively participate in the Capital District Regional Off+Track Betting Corporation, said corporation to implement the off-track betting system for the Capital District Region following approval of the addition of St. Lawrence County to participant status by the State Racing and Wagering Board.
- Section 3. Insofar as the provisions of this law are inconsistent with the provisions of any special laws, local laws, or resolutions, the provisions of this local law shall be controlling.
- <u>Section 4</u>. This local law shall take effect 45 days after adoption or upon approval of a majority of the electors vote, should a petition for a permissive referendum be filed pursuant to the provisions of Section 24 of the Municipal Home Rule Law.
