### LOCAL LAW NO. 11 FOR THE YEAR 1985

# PROVIDING FOR A PROPORTIONAL INCREASE OR DECREASE IN THE VETERANS EXEMPTION

Be it enacted by the Board of Legislators of the County of St. Lawrence as follows:

Section 1. The veterans exemption, provided by Section 458 of the Real Property Tax Law, shall be increased or decreased in proportion that the assessed valuation of real property on which the exemption has been granted is increased or decreased due to full value assessments in the County of St. Lawrence.

Section 2. This local law shall take effect immediately upon filing in the office of the Secretary of State.
