## LOCAL LAW NO. 20 FOR THE YEAR 1983

A LOCAL LAW TRANSFERRING RESPONSIBILITY FOR ENFORCEMENT OF THE NEW YORK STATE FIRE PREVENTION AND BUILDING CODE TO THE STATE OF NEW YORK

Be it enacted by the Board of Legislators of the County of St. Lawrence as follows:

Section 1. Pursuant to Article 18, Section 381 of the New York State Executive Law, the County of St. Lawrence declares that it will not enforce the New York State Fire Prevention and Building Code on or after January 1, 1984.

Section 2. This local law shall take effect immediately.
