Hermon and the Canton-Pyrites Road are still in abeyance. We are going ahead on the Murray Road Bridge in the Town of Brasher and the bridge in the Village of Hermon.

Mr. Thompson said we have a lot of vehicles that take unleaded gas and we have instructed the Highway Superintendent to take immediate steps to put an unleaded tank in the ground. They are still looking at the idea of a fuel island with gas, unleaded gas, and diesel fuel at the County Highway Department. Mr. Thompson stated the Superintendent has quite an extensive list of obsolete equipment which he wanted the authority to sell or trade-in so a Committee was appointed from our Committee to examine this equipment with representatives from the Highway Department and make a decision as to whether or not to repair or sell. Mr. Johnson and Mr. Smith have looked this equipment over and made recommendations which will be acted upon at our next Committee meeting which will be the last Tuesday in May. Mr. Thompson also reported there will be a tour of the Eastern side of the County this Thursday of proposed projects and roads with bridges and problems.

Mr. Thompson reported his Committee had a meeting with the representatives of the State Department of Transportation, the Town Highway Superintendents and Town Supervisors last Tuesday. Mr. Thompson said they got more information on what could be done with this State Bond Issue money and all the figures are available for the towns, villages, and the City of Ogdensburg on how much money they have to use. The County has \$800,000.00 and we are not sure yet how we can handle this money, whether by bid or not.

Mr. Smith, Chairman, Insurance Committee, reported his Committee had not met this past month, but they are planning a meeting in the near future to go over the County liability insurance policy.

Mrs. Bradley, Chairman, Audit Committee, reported her Committee met on May 8, 1980, and they reviewed the monthly report ending in April. Mrs. Bradley pointed out that Court costs have finally gone to the State and the last payment has been made on that account. Mrs. Bradley said they had checked on the sales tax coming in, but there was some concern when in the first quarter we were down \$18,700. However, it compared to last year and the second quarter came in higher in 1980, which put us \$15,273 over what we have received last year. Mrs. Bradley stated we had budgeted \$100,000 less this year in sales tax than we received last year, so we are very hopeful that that will hold up and we will get at least the \$5,700,000. Mrs. Bradley said next week that William Sheridan and Mrs. Bradley will be doing some spot check auditing in the areas of mileage and overtime in selected departments and we will make a report if we find any areas that we might feel some recommendations should be made.

Chairman Livingston stated it was time for presentation of resolutions.
