RESOLUTION NO. 158A-80

AMENDING THE 1980 BUDGET TO PROVIDE A SUMMER YOUTH EMPLOYMENT PROGRAM By Mr. Greco, Chairman, Finance Committee

WHEREAS, there are 100% funds available through the New York State Division For Youth to operate a Summer Youth Employment Program, and

WHEREAS, this Program will provide employment to 30 young people age 16-19, who have been involved with or who are substantially at risk of becoming involved with the justice system,
