RESOLUTION NO. 28-79

ADOPTING LOCAL LAW NO. 5 FOR THE YEAR 1979

WHEREAS, a public hearing has been held on February 12, 1979 regarding Local Law #5 for the year 1979, and

WHEREAS, prior notification of such local law was provided to the members of the St. Lawrence County Legislature,

NOW, THEREFORE, BE IT RESOLVED that Local Law No. 5 for the year 1979 is hereby adopted.

Mr. Greco called "Point of Information". Mr. Greco asked at one time why these local laws were coming out of the Legislative & Judicial Committee, rather than the Finance Committee, and he was told the reason was because the dollar amount talked to in these local laws was not a consideration and Mr. Greco is wondering really, that we are getting no votes here, passing any or all of these local laws is not voting in favor of the particular increase as Mr. Greco understands it, is that correct? Mr. Greco stated we already did this and our vote is a matter of record for or against a specific increase, so that all we are doing is formalizing what a majority of the Board decided previously, is that correct? Chairman Abrams stated that was correct.

Mr. Rishe called "Point of Information". Mr. Rishe asked if we are saying that if one of these local laws should go down to defeat that the salary presently received by one of these persons would be reverted back to before it was defeated.

Chairman Abrams stated that Mr. Greco didn't say that, to which Mr. Greco said "No, I didn't say that, however, I think if you want to pursue that line of reasoning, I think that the salary would go on the way it was promulgated that the people by virtue of a quasi contract, if the individual employee wanted to take us to task under a contract, I think we would have to pay for this as we advertised it that way," but Mr. Greco didn't think that was the issue. Mr. Greco wasn't talking to that thing anyway, that he just asked why it was coming out of that Legislative & Judicial Committee, when they said they were not talking money.

Mr. Healey stated he thought it was coming from the Legislative & Judicial Committee is the fact that County Law says you do not raise elective or appointed officers' salaries during a term of office and it came to my attention that we hadn't adopted a local law for these positions, but had been approved by the Legislature and Mr. Healey brought it to the attention of the Legislative & Judicial Committee meeting and it was decided that upon the recommendation of the County Attorney

that we would have to have the local laws.

Mr. Livingston made the motion to adopt resolution number 28-79, seconded by Mr. Greco.

On a roll call vote, resolution number 28-79 was carried with 19 yes votes, 1 no vote and 2 members absent, as follows:
