ADOPTING LOCAL NO. 8 FOR THE YEAR 1979 By Mr. Livingston, Chairman, Legislative & Judicial Committee

WHEREAS, a public hearing has been held on February 12, 1979 regarding Local Law No. 8 for the year 1979, and

WHEREAS, prior notification of such local law was provided to the members of the St. Lawrence County Legislature,

NOW, THEREFORE, BE IT RESOLVED that Local Law No. 8 for the year 1979 is hereby adopted.

Mr. Livingston made a motion to adopt resolution number 31-79, seconded by Mr. Greco.

Mrs. Bradley stated she was going to vote against this resolution and that she wanted to say why. Mrs. Bradley stated it seemed a year ago when this position was filled, the salary had been \$17,600.00 and Mr. Greco at the time brought up that that was a large increase by not going on to the grade and step of the original level at which this position was created. This means that this position would be increased now by \$7,000.00 in one year time and Mrs. Bradley didn't think the job description was changed any, so that Mrs. Bradley finds it difficult to vote for that kind of an increase in a one year period, especially when you add fringe benefits and it is up around \$10,000.00 that that position was increased in the cost, particularly when you have an accountant at \$18,000.00 who will be absorbing some of the work in that office.

Mr. Greco just wanted to state to Mrs. Bradley that he didn't know how she could make such a remark as that, when in fact last year, the salary was decreased from the previous year. Mr. Greco asked Mrs. O'Neil if she got less money than her predecessor, Mrs. O'Neil said "yes, but I believe Mrs. Bradley is making reference to the work in the office and is questioning now the salary being paid to the new administrative assistant, after me." Mrs. Bradley said "yes."

Mr. Greco said he opposed the whole administrative assistant.

LOCAL LAW NO. 8 FOR THE YEAR 1979

A LOCAL LAW ESTABLISHING THE SALARY FOR THE ADMINISTRATIVE ASSISTANT ST. LAWRENCE COUNTY LEGISLATURE
