## LOCAL LAW NO. 12 FOR THE YEAR 1979

#### A LOCAL LAW ESTABLISHING THE RATE FOR EXEMPTION FOR PERSONS 65 YEARS OF AGE OR OVER FOR COUNTY TAX PURPOSES AT THE LEVEL OF \$6,000.00

Be it enacted by the Board of Legislators of St. Lawrence County as follows:

Section No. 1. In accordance with the provisions of Section 467 of the Real Property Tax Law of the State of New York, persons 65 years of age or older shall be exempt of 50% of the assessed valuation of real property providing that the income for

the tax year immediately preceding the date of application for exemption does not exceed \$6,000.00 as set forth in provisions of Section 467 of the Real Property Tax Law.

Section No. 2. This Local Law shall take effect upon its being duly filed as provided in the Municipal Home Rule Law in the State of New York.
