## LOCAL LAW NO. 13 FOR THE YEAR 1979 A LOCAL LAW ESTABLISHING A DEPARTMENT OF DATA PROCESSING

Be it enacted by the Board of Legislators of the County of St. Lawrence as follows

Section 1. For the purpose of providing a centralized Data Processing facility servicing various St. Lawrence County Departments, there is hereby established a Department of Data Processing of the County of St. Lawrence.

Section 2. The head of said department shall be the Director of Data Processing who shall be appointed by the Board of Legislators of St. Lawrence County.

Section 3. The term of office for the Director of Data Processing shall be 5 years.

Section 4. The salary for the Director of Data Processing shall be set by the Board of Legislators of St. Lawrence County.

Section 5. The duties of the Director of Data Processing shall be to direct all authorizations of the County Data Processing Center and to have and perform all the powers and duties conferred on department heads by the County Law, the General Municipal Law, and any other general or special law of the State of New York. The said director shall be responsible for technical, supervisory, and administrative work in the

planning, scheduling and direction of all production activities and personnel of the County Data Processing center and shall perform such additional and related duties as may be prescribed and directed by the Board of Legislators of the County of St. Lawrence. He shall have the supervision and control of all persons employed in the Department of Data Processing.

Section 6. This local law shall take effect immediately upon the filing of a certified copy in the Office of the Secretary of the State of New York.

#### **RESOLUTION NO. 306-79**

### ESTABLISHING A PROCEEDURE FOR DETERMINING WORK SCHEDULES By Mr. Greco

WHEREAS it is in the best interest of County Government, and the responsible administration thereof, to exercise reasonable control over hours of work and the scheduling of all employees, and

WHEREAS the Supreme Court has pointed out that St. Lawrence County Government, through its Administrative Branch the County Board, has neglected to adequately meets its administrative responsibilities in the past, and

WHEREAS there is no present system for knowing the whereabouts of Department Heads in regards to whether or not they are scheduled for work, on vacation, off sick, or merely absent from work.

NOW THEREFORE BE IT RESOLVED that all Department Heads will submit an intended vacation schedule to the Administrative Assistant, or Chairman of the Board, for each ensuing year, on or before March 1st of that year.

BE IT FURTHER RESOLVED, if any Department Head fails to express in writing, their choice as to the days or weeks which they will be on vacation, on or before March 1st of each year, the Administrative Assistant will so notify the Board at the regular March meeting, and the Board will take steps to schedule such Department Heads' vacation, in keeping with the orderly operation of the respective Department assuming such employee does not have a preference.

BE IT FURTHER RESOLVED nothing in this resolution is intended to take away the employees choice, or their right to re-schedule such vacation where they previously indicated a choice so long as proper notification is given.

Mr. Greco made a motion to adopt resolution number 306-79, seconded by Mr. LaBaff.

Mr. Hess made a motion that resolution number 306-79 be referred back to the Finance or Personnel Committee, whichever is appropriate, for further determination and recommendation. Seconded by Mr. Peters

Mr. Marscher made a motion to close debate, seconded by Mr. Hess. By a roll call vote, as shown below, there were thirteen yes votes and nine no votes, and as it was not a two-thirds vote, the motion was defeated.
