NOW THEREFORE BE IT RESOLVED, that the St. Lawrence County Board of Legislators authorizes the Chairman to sign an agreement with the Canton Agricultural and Technical College for the rental of the abovementioned space at an amount not to exceed \$5,600 annually, such funds to be fully paid for by the federal monies available to the CETA program.

Mr. Hess moved for adoption of this resolution, seconded by Mr. Bell.

Mr. Hess then requested that Mr. Doane give a brief explanation of the necessity of this resolution.

Mr. Doane said the Employment & Training Department was in need of additional office space and although ATC has space available, they still have not given him the contract for review.

LOCAL LAW NO. 2 FOR THE YEAR 1978 A LOCAL LAW INCREASING THE ANNUAL SALARY FOR THE OFFICE OF COMMISSIONER OF SOCIAL SERVICES

Be it enacted by the Board of Legislators of the County of St. Lawrence as follows:

Section 1. The annual salary for the office of Commissioner of Social Services shall be increased \$2,000.

Section 2. This Local Law shall take effect 45 days following its adoption by resolution of the St. Lawrence County Board of Legislators.

Section 3. This increase in salary shall be paid in equal installments beginning on the effective date of this Local Law through the remainder of 1978.
