ST. LAWRENCE COUNTY LOCAL LAW NO. 1 FOR THE YEAR 1971

BE IT ENACTED by the Board of Supervisors of St. Lawrence County as follows:

Section 1.

The annual salary for the office of County Court Judge shall be \$28,000.00.

The annual salary for the office of Family Court Judge shall be \$28,000.00.

The annual salary for the office of Surrogate Judge shall be \$26,000.00.

The annual salary for the office of Commissioner of Elections shall be \$7,800.00.

The annual salary for the office of County Coroner shall be \$1,040.00.

The annual salary for the office of Superintendent of Highways shall be \$19,760.00.

Section 2. This Local Law shall take effect on the first day of the month immediately following the filing of a certified copy in the Office of the Secretary of State, and upon approval by the electors or upon the expiration of time for the filing of a petition by said electors.
