If you have a New York State driver license, learner permit or non-driver ID card, an enhanced driver license, learner permit or non-driver ID Card, or a registration for a vehicle, boat or snowmobile, you are required by law to notify Motor Vehicles within 10 days of any PERMANENT address change. Please use this form to do that. Do **NOT** report temporary changes (such as school or military addresses).

If you have unpaid Traffic Violations Bureau tickets, in addition to reporting your address change on this form, <u>you must also call</u> (718) 488-5710 (NYC and Suffolk County TVB offices) or (518) 474-0941 (Buffalo and Rochester TVB offices) to report your address change and to make arrangements to pay your traffic ticket fines. For TVB office locations and phone numbers, see the "Local Offices" pages at the DMV web site.

## **OPTIONS**

- If your state or enhanced license, permit, non-driver ID card or registration will expire in the next 90 days, call Motor Vehicles (see the phone numbers listed above) for information about changing your address and renewing your document by mail at the same time.
- Motor Vehicles does not require you to get a new state or enhanced license, permit, non-driver identification card
  or registration document, but many people prefer to do so. You can use this form to purchase replacement
  documents by mail.

To purchase a replacement state or enhanced driver license, permit, non-driver ID card or registration document showing your new address, follow the instructions on Page 2 and complete Parts 1 and 2. If you request a replacement state or enhanced license, permit, non-driver ID card, or registration document, keep your current one until you receive the new one in the mail.

- If you DO NOT want a new document, we will enter your address change in our records at no cost to you. On Page 2, fill in all of the information requested in Part 1, and mail it to the address in #5 near the bottom of the page.
- FOR YOUR CONVENIENCE If you want us to send this change of address information to your County Board of Elections <u>for voting</u> purposes, please check the "Yes" box on Page 2. You will be notified by the Board of Elections when your address change has been processed.

**NOTE:** If you are <u>moving to a different county</u>, you <u>must</u> register with that County's Board of Elections by completing a NYS Voter Registration Form that is available at any Motor Vehicles office, from your County Board of Elections, or by visiting the NYS Board of Elections web site at www.elections.state.ny.us.
