9. COUNTY ADMINISTRATOR'S REPORT

Ms. Doyle reported three (3) transfer of funds: \$5,000 for the Highway Department for equipment parts; \$1,000 for the County Administrator's Office for advertising; and \$721.74 for the County Clerk for cleaning services and postage.

Ms. Doyle said the current positivity rate reported today for the County is 16.6 %; per 100,000 rate is 831.6% with twenty-nine (29) hospitalized. The rate for first vaccination is up a half of percent and is 63.2%; fully vaccinated is 59.2%; and boosters are up 2.2% at 51.2%. Booster clinics are scheduled in Gouverneur, Ogdensburg, and Massena. A plan will be made for distribution as supplies arrive. Public Health is transitioning to new guidance regarding coronavirus as contract tracing goes away.

For the sixth year in a row, with an exception of 2021, a legislative work session was held for 2022. The success rate of the Legislative Agendas is forty percent (40%) immediate success of items brought forward, and ten percent (10%) success achieved later from the initial request, and fifty (50%) of requests were unsuccessful. A resolution will come to the next Finance Committee for consideration.

The NYSAC Conference is scheduled for March 14-16th.

Ms. Doyle said the year 2022 marks the 220 anniversary of the incorporation of St. Lawrence County on March 3rd. There will be celebratory activities scheduled in March.

The successes and challenges of the Social Services satellite location in Ogdensburg are being evaluated and information will come to the March Services Committee.

The Bonadio Group have reviewed the majority of the Child Protective Services, and are now focusing on Foster Care and Preventive. They have reviewed documentation received from complainants and they are making determination on who they plan to meet with. There will be a written report provided in February.

The fourth quarter report for 2021 will be provided at the Finance Committee, along with resolutions regarding solar, legislative agenda, and tribal state compact funds.
