McQuade suggested that the Code Enforcement track might be cancelled in order to make room for the FH track. McQuade's reasoning was that most CEOs will have already accumulated the required hours of Continuing Ed credits before October.
 - Tenbusch will let Jason Pfotenhauer know about these requests. (Note: Pfotenhauer is on the Organizing Committee for the LGC.)
- b. On a motion from J. O'Neill (D. Dufresne), the FHTF approved a resolution thanking Matilda Larson for her years of service to the FHTF. Tenbusch will draft an appropriate resolution, have F. Hanss sign it. It can be awarded to Matilda at the next FHTF meeting in May.
