8. VACANCY REVIEW COMMITTEE - RUTH DOYLE

A. Public Health – Ms. Munger requested to abolish an Account Clerk Typist, and create and fill Senior Account Clerk, Position No. 100200043, in Public Health.

B. Social Services – Mr. Seeber requested to fill Homemaker, Position No. 805000002, and abolish a Caseworker and create and fill Homemaker, Position No. 805000006, in Social Services.

9. COUNTY ADMINISTRATOR'S REPORT

Ms. Doyle said Public Health Director Jolene Munger will give a brief update on the changes made by the Center for Disease Control (CDC) regarding quarantine for Covid. Ms. Munger said late Thursday afternoon the CDC made changes to the regulations for community members only. They are no longer recommending a quarantine if exposed, but to wear a mask for ten (10) days, and if symptoms develop, test on day five. For a positive test, there is still a five day isolation period. The CDC has also removed all the quarantine and testing for schools.

Ms. Doyle said the annual Senior Picnic was a success with 225 seniors being served lunch. There were over fifty (50) volunteers.

The County is moving forward with the Health Care bonuses and are evaluating the Departments affected. It appears there may be thirty (30) to forty (40) titles involved, and this will go through March 31, 2024.

A third round of septic tank replacement funds in the amount of \$595,000 has been awarded to St. Lawrence County.

Three (3) staff and three (3) incarcerated persons at the jail have been diagnosed with Covid this week.

There will be a bench dedication in memory of former County Clerk Mary Lou Rupp on Monday, September 12th, prior to the Board Meeting.

Budget reviews are ongoing.

Ms. Doyle will discuss the annual review of vacancies for the year on August 29th at Finance Committee.

Ms. Curran called the questions, seconded by Mr. Forsythe, and carried by a voice vote with thirteen (13) yes votes, and two (2) absent (Haggard and Perkins).

Motion carried by a voice vote with twelve (11) yes votes, two (2) no vote (Fiacco and Smithers), and two (2) absent (Haggard and Perkins).
