- 1. CALL TO ORDER AND APPROVAL OF AGENDA Chair Timmerman called the meeting to order at 5:30 p.m. Mr. Forsythe moved to approve the agenda, seconded by Mr. Fay, and carried by a voice vote with thirteen (13) yes votes, and two (2) absent (Colbert and Leader).

7. WORKFORCE DEVELOPMENT BOARD

Tom Plastino spoke to the following resolution:

Authorization to Modify the PY17 WIOA Budget to Transfer Formula Funds from Dislocated Worker Accounts to Adult Accounts (Res) – Mr. Hooper moved to forward this resolution to full Board, seconded by Mr. Forsythe, and carried by a voice vote with thirteen (13) yes votes, and two (2) absent (Colbert and Leader).

Mr. Plastino said the Investing in Opportunity Act went into effect, which authorizes the designation of opportunity zones in low-income communities and provides tax incentives for investments in the zone, including deferring the recognition of capital gains that are reinvested in the zones. He suggests a resolution asking the Governor to designate St. Lawrence County as an Opportunity Zone. The recommendation has to be done by March 21st.

8. EMERGENCY SERVICES – MICHAEL LECUYER

A. Modifying the 2017 Budget for the Office of Emergency Services Due to a Budget Modification of the FY13 SICG Grant (Res) – Mr. Denesha moved to forward this resolution to full Board, seconded by Mr. Burke, and carried by a voice vote with thirteen (13) yes votes, and two (2) absent (Colbert and Leader).

9. SOCIAL SERVICES - CHRIS REDIEHS

A. Modifying the 2017 Budget for the Public Health Department for an Increase in Expenses to the Coroners Program (Res) – Mr. Burke moved to forward this resolution to full Board, seconded by Mr. Perkins, and carried by a voice vote with thirteen (13) yes votes, and two (2) absent (Colbert and Leader).

11. COUNTY ADMINISTRATOR'S REPORT - RUTH DOYLE

Ms. Doyle said there was a request from Franklin County for us to provide assistance to them in response to recent flooding in that area. The Public Health Department was providing both POD (Point of Dispensing) exercise and tetanus vaccinations on the reservation. The Public Health Staff, admirably, stepped up and made themselves available. Ms. McGuire was available throughout the course of the weekend, and Mr. Button came in on the weekend to put together the agreement, but in the end Franklin County was unable to secure the ability for us to be on site. Ms. Doyle said that Ms. McGuire will attend the after action meeting.

A. Recommending the 2018 New York State Legislative Agenda for St. Lawrence County (Res) – Mr. Denesha moved to forward this resolution to full Board, seconded by Mr. Perkins, Ms. Bell, and Mr. Lightfoot, and carried by a voice vote with thirteen (13) yes votes, and two (2) absent (Colbert and Leader).

B. Transfers of Funds: Ms. Doyle reported a transfer of funds for the Sheriff's Office in the amount of \$4,000 to cover medical supplies and a transfer of funds for Office for the Aging in the amount of \$50 for nutrition.

Ms. Doyle said she attended the Association of Towns Conference, and she will bring information on that conference to the Full Board Meeting.

The Ogdensburg shuttle began today with Legislator Hooper presiding over the ceremony. Legislator Lightfoot was also in attendance.

A. Resolution No. 246-2017 Date Amendment (Discussion) – Ms. Doyle said the deadline date on the resolution regarding the Legislative Salary Review will be moved to the March Finance Committee.

Mr. Forsythe asked what the NYPA high-flow payments are for the Village and Town of Waddington. Ms. Cole said the distribution for the Village of Waddington is \$41,776.95, and the distribution for the Town of Waddington is \$83,553.91.

Mr. Perkins said that he has listened to the recordings of the meetings and there is a lot of dead air on the recordings. He would like to have something done with the microphone, if possible, to address these issues.
