


PROPOSAL NUMBER ONE, AN AMENDMEN


Amendment to Allow Olympic Sports Complex in Essex County on State Forest Preserve Land

Allows skiing and related trail facilities on state forest preserve land. The site is 1,039 acres. Requires State to add 2,500 acres of new forest land in Adirondack Park. A "YES" vote authorizes new ski trails and related facilities in the Adirondack forest preserve. A "NO" vote does not authorize this
