AUTHORIZING THE CHAIR TO SIGN A CONTRACT WITH MOTOROLA SOLUTIONS, INC. FOR THE PURCHASE OF PUBLIC SAFETY COMMUNICATIONS EQUIPMENT, SOFTWARE, AND APPLICABLE MAINTENANCE SERVICES AND AUTHORIZING A LEASE PURCHASE FOR EQUIPMENT

By Mr. Acres, Chair, Finance Committee

- WHEREAS, Emergency Services currently maintains a Very-High Frequency (VHF) analog un-encrypted radio system for fire departments, ambulance services, and law enforcement agencies operating within the County, and
- **WHEREAS**, the current VHF radio system, which was implemented in 1988, replaced the previous low-band option owned and maintained by St. Lawrence County, and
- WHEREAS, the current VHF radio system relies on antiquated and outdated equipment that is no longer supported by the manufacturer, some of which has started to fail in a faster progression than anticipated, and
- WHEREAS, the current VHF radio system is experiencing frequent interruption, consistent static, intentional and unintentional unauthorized transmission on public safety frequencies, and overall coverage degradation as technology evolves causing an extreme deficit to public safety and the safety of responders in the County, and
- **WHEREAS,** to explore the mitigation of these issues, Resolution No. 141-2014 authorized the use of Blue Wing Services to conduct a Communications Study and act as the public safety communications consultant, and
- WHEREAS, Blue Wing Services assisted in the planning and construction of multiple public safety radio towers in Colton, Waddington, Hammond, Gouverneur, Massena, Russell, and Ogdensburg to assist in increasing the overall radio coverage, and
- WHEREAS, Blue Wing Services recommends that in addition to the towers constructed, an overhaul of the current radio system is required to mitigate the issues faced and increase overall coverage, which will include switching from the current Very-High Frequency (VHF) band to a Ultra-High Frequency (UHF) band, and
- WHEREAS, the Office of Emergency Services Radio Committee endorses the recommendations and plans set forth by Blue Wing Services, and
- **WHEREAS,** St. Lawrence County issued a Request for Proposals on March 28, 2022, utilizing the recommendations of Blue Wing Services, to which St. Lawrence County received three (3) responses, and

- WHEREAS, utilizing a scoring matrix, Motorola Solutions (Hereinafter referred to as "Motorola") was selected as the optimal company to provide the services required to completely overhaul the St. Lawrence County Radio system by Blue Wing Services, the Office of Emergency Services Radio Committee, and the Office of Emergency Services, and
- WHEREAS, the proposal from Motorola was the lowest cost out of all the proposals received, totaling \$12,150,000, and
- WHEREAS, the proposal includes the supply of tower-related radio hardware and equipment, dispatch center-related radio hardware and equipment, subscriber portable and mobile radios, applicable software, installation services, training, and warranty and maintenance services for ten years, and
- WHEREAS, St. Lawrence County is able to provide \$8,000,000 in funding; \$5,000,000 has been dedicated from County American Rescue Plan Act Funds per Resolution No. 181-2022, and \$3,000,000 has already been accepted from the New York State Division of Homeland Security FY18 Statewide Interoperable Communications Targeted Grant (X2Z36402 25000 SICG), and
- **WHEREAS**, the remaining \$4.15M would be recommended to finance through a municipal lease with Motorola with an interest rate of 4.99% for five years, equating to an annual payments of \$958,227.74,
- NOW, THEREFORE, BE IT RESOLVED that the Board of Legislators authorizes the Chair to sign a contract with Motorola Solutions for the purchase of Public Safety Communications Equipment, Software, and Applicable Maintenance Services, and authorizing a lease purchase for equipment, upon approval of the County Attorney, and
- **BE IT FURTHER RESOLVED** that the Board of Legislators authorizes the Chair to enter into a municipal lease purchase for the balance due and owing of the \$12.15M Radio Communication Project, and
- **BE IT FURTHER RESOLVED** that the Board of Legislators authorizes the Chair to sign a contract with Motorola Solutions for warranty and maintenance services for ten (10) years, upon approval of the County Attorney.

WHEREAS, the Department completed the additional ten (10) miles of road with funds remaining, and

WHEREAS, costs associated with road maintenance projects saw significant and unpredictable increases with the escalation of asphalt pricing throughout the paving season,

APPROVING BRIDGE NY FUNDED HIGHWAY PROJECT FOR LAZY RIVER ROAD BRIDGE OVER GRASSE RIVER, BIN 3341820, PIN 775379

By Mr. Acres, Chair, Finance Committee

Authorizing the Implementation and Funding of the Costs of 100% of the Costs of a Transportation Project, of which Qualified Costs may be Reimbursed from Bridge NY Funds.

WHEREAS, a project for the Final Design Phase for the Lazy River Road Bridge over Grasse River, BIN 3341820, PIN 775332 (the "Project") is eligible for reimbursement of qualified costs from BRIDGE NY funding that calls for the post-reimbursement apportionment of the qualified costs to be borne at the ratio of ninety-five percent (95%) BRIDGE NY funds and five percent (5%) non-Federal funds, and

WHEREAS, the Board of Legislators desires to advance the project by making a commitment of one-hundred percent (100%) of the costs of the Final Design phase for the Project or portions thereof,

NOW, THEREFORE, BE IT RESOLVED that the Board of Legislators approved Bridge NY funded Highway Project for Lazy River Road Bridget over Grasse River, BIN 3341820, PIN 775379, and

BE IT FURTHER RESOLVED that the Board of Legislators authorizes the Treasurer, to pay in the first instance one-hundred percent (100%) of the cost of Final Design work for the Project or portions thereof, with the understanding that ninety-five percent (95%) of qualified costs will be reimbursed from BRIDGE NY funding, and

BE IT FURTHER RESOLVED that the Board of Legislators hereby agrees that the St. Lawrence County shall be responsible for all costs of the Project, including costs which exceed the amount of reimbursement available from the NY Bridge Funding awarded to the Department of Highways, and

BE IT FURTHER RESOLVED that in the event the costs of the Project exceed the amount appropriated above, the Board of Legislators shall convene as soon as possible to appropriate said excess amount immediately upon the notification by the Department of Highways thereof, and

BE IT FURTHER RESOLVED that the Board of Legislators agrees that construction of the Project shall begin no later than twenty-four (24) months after award and the construction phase of the Project shall be completed within thirty (30) months, and

BE IT FURTHER RESOLVED that the Board of Legislators authorizes the Chair to sign all necessary agreements, certifications, or reimbursement requests for NYSDOT for State Aid and/or BRIDGE NY funding in connection with the advancement or approval of the Project and providing for the administration of the Project and on behalf of the municipality's funding of the Project costs, upon approval of the County Attorney, and

BE IT FURTHER RESOLVED that the Department of Highways will be responsible for all maintenance of the Project, and

BE IT FURTHER RESOLVED that a certified copy of this resolution be filed with the New York State Commissioner of Transportation by attaching it to any necessary Agreement in connection with the Project, and

BE IT FURTHER RESOLVED that this resolution shall take effect immediately.

WHEREAS, an Environmental Assessment Forms (EAF) identifying and assessing the potential adverse environmental impacts associated with the proposed construction has been prepared and distributed in an electronic version to the members of this Board for review, and

WHEREAS, the preparation of the EAF incorporated data was collected from the following sources: NYS Department of Environmental Conservation critical habitats databases, NYS Office of Parks, Recreation and Historic Preservation information on archeological sites and concerns, state and federal wetlands delineation maps, internal engineering assessments, soil maps and soil boring data, a site survey and assessment of design considerations that may be incorporated to minimize adverse impacts, and

WHEREAS, the County determined that there are other "involved" agencies and will be proceeding with coordinated review for unlisted actions,

NOW, THEREFORE, BE IT RESOLVED that the Board of Legislators authorizes the issuance of a negative declaration related to replacement of Lazy River Road Bridge, PIN 7753.23, BIN 3341820, and

BE IT FURTHER RESOLVED that based upon the environmental assessment and supporting materials the Board of Legislators has determined that the development of this project will not result in any significant adverse environmental impacts, and

BE IT FURTHER RESOLVED that the Board of Legislators directs the County Administrator to prepare a "Negative Declaration" which indicates that the Board of Legislators determines that the no adverse environmental impacts will result from this Project based upon the summary of environmental impacts as described in the EAF and Board discussion of this resolution, and

BE IT FURTHER RESOLVED that the Board of Legislators directs the County Administrator to file the "Negative Declaration" in compliance with the requirements of § 617.12; determines that completion of this environmental review fulfills the requirement of the Board under SEQRA; and further determines that the Board is free to take "actions" on the project as defined under 6 NYCRR Part 617.

AUTHORIZING THE CHAIR TO SIGN A LEASE AGREEMENT WITH LOT 21 FOR SPACE LOCATED AT 206 FORD STREET, OGDENSBURG, NEW YORK, FOR PROPERTY TAX COLLECTION

By Mr. Acres, Char, Finance Committee

WHEREAS, property taxes due to St. Lawrence County for property located within the City of Ogdensburg has historically been collected by the City and remitted to the County, and

WHEREAS, in 2021, the City of Ogdensburg took formal action to cease collection of property taxes due to St. Lawrence County, and

WHEREAS, Resolution No. 396-2021 authorized the Chair to sign a lease agreement with Lot 21 for space located at 206 Ford Street, Ogdensburg, New York, for property tax collection for time period of January 1, 2022 through May 31, 2022, and

WHEREAS, for 2023, there is once again a need for short-term office space within the City of Ogdensburg to provide a location for citizens to pay property tax due to St. Lawrence County, and

WHEREAS, the space located at 206 Ford Street, Ogdensburg is available and would provide a centralized location adjacent to County services, currently occupied by the Department of Motor Vehicles, Probation, and Community Services' Addiction Services Clinic, and

WHEREAS, the terms of the agreement will be for five (5) months for approximately 450 square feet of space, and will commence on January 1, 2023 through May 31, 2023, and

WHEREAS, the rental rate per square foot will be \$1.02 per square foot per month for a rate of \$459 monthly (T3012154 40700),

NOW, THEREFORE, BE IT RESOLVED that the Board of Legislators authorizes the Chair to sign a lease agreement with Lot 21 for space located at 206 Ford Street, Ogdensburg, New York, for property tax collection, upon approval of the County Attorney, and

BE IT FURTHER RESOLVED that the rental rate will be \$1.02 per square foot per month, for a term to commence on January 1, 2023 through May 31, 2023.

WHEREAS, the County commenced an In Rem real property tax foreclosure proceeding for delinquent taxes pursuant to Article 11 of the Real Property Tax Law against property owned by Lewis Herne known as "The Herne Property", located at 47 South Raquette Street in the Town of Massena, County of St. Lawrence, State of New York (Tax Map No. 16.027-3-3) (hereinafter referred to as the "Property"), and

WHEREAS, there are currently delinquent real property taxes due and owing in the amount of \$16,655.56, together with fees, penalties and interest in the amount of \$7,755.54 for a total of \$24,411.10 on the Herne Property, and

WHEREAS, the Property is believed to be potentially contaminated from historic activities on and adjacent to the Property, and

WHEREAS, the County desires to have an environmental investigation conducted on the Property to obtain information about the environmental conditions, including the nature and extent of any discovered contamination, so that the County can make an informed decision concerning the Property prior to a judgment of foreclosure being entered, and

WHEREAS, in addition, the County, through its outside environmental council, has secured a proposal with the scope of work involving a limited site environmental investigation of the parcel and preparation of a written report describing environmental conditions, if any, to the County if it proceeds with tax foreclosure and acquires this parcel, and

WHEREAS, the County Attorney and Consultant, Gary Bowitch, Esq. have reviewed the proposal and recommend awarding the contract to C&S Companies,

NOW, THEREFORE, BE IT RESOLVED the Board of Legislators authorizes the Chair to sign a contract with C&S Companies, in the amount of \$9,000 (T1013254 43007), for environmental investigation on property owned by Lewis Herne, upon the approval of the County Attorney.

MODIFYING THE 2022 BUDGET FOR THE ST. LAWRENCE COUNTY SELF-INSURANCE PLAN FOR INCREASED COSTS OF SCHEDULED LOSS OF USE AWARDS

By Mr. Acres, Chair, Finance Committee

WHEREAS, the Self-Insurance Fund is responsible for the payment of Workers' Compensation related expenditures, and

WHEREAS, part of the administration of the Workers' Compensation claims requires an assessment of files that may not be prepared for full and final settlement, but where a claimant has reached maximum medical improvement, and

WHEREAS, under New York Workers' Compensation Law, a Schedule Loss of Use Award may be made when a claimant has reached maximum medical improvement and the body part(s) of the claimant have a permanent loss of use as a result of their work-related injury, and

WHEREAS, under a Schedule Loss of Use Award, compensation is limited to a certain number of weeks based on the body part and severity of the disability, according to a schedule set by law, and

WHEREAS, a credit will be realized from the fact that the temporary benefits that have been paid are deducted from the total Scheduled Loss of Use Award, and future full and final settlements are reduced by that credit as an advance against the final value of the claim, and

WHEREAS, these Scheduled Loss of Use Awards are largely viewed within the industry as the end of claim incapable of being fully and finally settled due to some other impediment such as continued employment, and

WHEREAS, these Scheduled Loss of Use Awards, common during economic, downturns, have created a deficit in the Benefits and Awards account which also covers the medical and indemnity payments of the claimants, and

WHEREAS, County Law, Article 7, Sections 363 and 366, allows the Board of Legislators to make additional appropriations or increase existing appropriations from the unappropriated fund balance within a particular fund, and

WHEREAS, it is necessary to transfer money from the Self-Insurance Plan Reserve account, by increasing the appropriated fund balance to cover those payments as they come due,

NOW, THEREFORE, BE IT RESOLVED that the Board of Legislators authorizes the Treasurer to modify the 2022 Budget for the St. Lawrence County Self-Insurance Plan for increased costs of Scheduled Loss of Use Awards, as follows:

WHEREAS, one of the stated purposes of the St. Lawrence County Ethics Law is to ensure compliance with all federal, state, and local laws and directives, and

WHEREAS, one such set of laws and directives, arising from general guidance published by the United States Office of Inspector General (OIG) of the U.S. Department of Health and Human Services, the U.S. Department of Justice Federal Sentencing Guidelines (U.S.S.G. §§ 8B2.1), and New York State Social Services Law SOS § 363-d, requires the establishment and implementation of a Corporate Compliance Plan as an entity that provides services to Medicaid recipients, and

WHEREAS, the St. Lawrence County Risk Manager has developed a Corporate Compliance Plan which incorporates the St. Lawrence County Ethics and Disclosure Law and sets forth the Standards of Conduct and Policies and Procedures to be followed by all St. Lawrence County employees and agents who furnish services and goods to St. Lawrence County,

NOW, THEREFORE, BE IT FURTHER RESOLVED the Board of Legislators hereby adopts the St. Lawrence County Corporate Compliance Plan, and

WHEREAS, for those taxing jurisdictions that have not opted out of RPTL Section 487; pursuant to RPTL Section 487(9)(a), such a taxing jurisdiction could indicate its intent to require a PILOT Agreement with the developer, under which the developer (or any successor owner of the Project) will be required to make annual payments to the taxing jurisdiction for each year during the term of the PILOT Agreement, and


WHEREAS, the St. Lawrence County Industrial Development Agency manages the PILOT negotiation process for St. Lawrence County with developers of such solar energy systems, and

WHEREAS, the Company seeks to enter into a payment in lieu of tax agreement with St. Lawrence County pursuant to the following terms:

- Fifteen-year payment in lieu of tax agreement pursuant to Real Property Tax Law Section 487,
- \$5,000 per MW payment to the effected jurisdictions, increasing 2% annually during the term of the agreement; and distributed to St. Lawrence County, Madrid-Waddington School and Town of Madrid based on their pro-rata property tax distribution, and

NOW, THEREFORE, BE IT RESOLVED that the Board of Legislators approves payment in lieu of taxes agreement in relation to solar project on parcel 40.004-2-20.22/1, located at 50 Cogswell Corners Road, Madrid, upon approval of the County Attorney, and

BE IT FURTHER RESOLVED that the Board of Legislators authorizes the Industrial Development Agency to finalize the execution of payment in lieu of tax agreement for the County pursuant to the terms set forth and to administer the billing and collection for the County for the term of the PILOT, upon approval of the County Attorney.

CALLING ON THE STATE OF NEW YORK TO FULLY FUND COUNTY LAW 18B ASSIGNED COUNSEL STATUTORY PAY LEVELS

By Mr. Acres, Chair, Finance Committee

WHEREAS, the United States Constitution established, and the Supreme Court decision Gideon v. Wainwright clarified, that competent counsel is to be given to all accused of a crime, regardless of their ability to pay, and

WHEREAS, New York State took legislative action to establish a criminal indigent defense legal system that passed the responsibility of providing these criminal defense services, and many of the costs associated with them, to counties and local property taxpayers, and

WHEREAS, in 2007, the New York State Civil Liberties Union sued the State of New York in Hurrell-Harring v. State of New York, which showed indigent criminal defense services were underfunded by the State and failed to meet constitutionally required standards, and

WHEREAS, prior to Hurrell-Harring, the 57 New York Counties spent \$164 million annually on public defense while the State provided the 57 Counties with only \$39 million in indigent defense support, and

WHEREAS, the New York State Legislature recognized that the State needs to provide additional funding and, in 2017, passed historic legislation allocating \$250 million per year, when fully implemented, of state funding to directly improve indigent defense services, and

WHEREAS, while counties are still funding the same amount, the 2017 funding increase has made New York State a leader in indigent defense services, and

WHEREAS, due to different county demographics and needs, counties have flexibility in how to provide criminal defense by using a combination of public defenders, conflict defense offices, and private contracted attorneys known as 18B counsel (named after the applicable section of County Law), and

WHEREAS, all counties rely on the services of 18B attorneys to perform these services to handle the overflow of work and handle conflicts that come into the public defender's office, and

WHEREAS, unfortunately, the 2017 State legislation did not address the pay rate for 18B attorneys, and

WHEREAS, Article 18B establishes compensation paid to attorneys for assigned counsel work at \$60/hour for misdemeanor matters and \$75/hour for felony defense, and

WHEREAS, these rates have remained unchanged since 2004 and, in that same time period, the United States has seen inflation rise by fifty-seven percent (57%), and

- WHEREAS, counties across the State have had difficulty in recent years attracting and keeping quality 18B attorneys in their region, with stagnate pay reported as the major contributing factor, and
- WHEREAS, without properly funding 18B attorneys, which will keep and attract quality attorneys, the good work by the State to improve indigent defense services could be in jeopardy,
- **NOW, THEREFORE, BE IT RESOLVED** that the Board of Legislators calls on the State of New York to increase the 18B assigned counsel statutory pay levels, and
- **BE IT FURTHER RESOLVED** that the State needs to fully fund this increase in keeping with the reasoning set forth in the Hurrell-Harring case, and to build on the State Legislature's historic 2017 legislation, and
- **BE IT FURTHER RESOLVED** that certified copies of this resolution be forwarded to Governor Kathy Hochul; Senator Joseph Griffo; Senator Patricia Ritchie; Senator Dan Stec; Assemblyman Ken Blankenbush; Assemblyman Billy Jones; Assemblyman Robert Smullen; and Assemblyman Mark Walczyk.

CALLING ON NEW YORK STATE TO SUFFICIENTLY INVEST IN 9-1-1 FUNDING TO ENSURE PROPER MAINTENANCE WITH EXISTING SYSTEMS AND PREPARE FOR NEXT GENERATION 9-1-1 TECHNOLOGIES

WHEREAS, the funding mechanism that New York State counties use to help operate, maintain and upgrade 9-1-1 system capability and performance is out of date and does not correspond well with recent technology and marketplace changes, and

WHEREAS, the FCC has released their latest report for 2020, and its shows that New York collected \$241,643,008 and diverted over \$100,765,134 (41.7%) to other non-9-1-1 related purposes and the general fund, and

WHEREAS, currently, Tax Law, Article 186-f, Section 5, states that forty-one and seven-tenths of the revenues collected and received are swept into the state general fund and not provided for public safety services, and

WHEREAS, this diversion shifts the bulk of Next Generation 9-1-1 (NG 9-1-1) readiness financing to counties and other local governments PSAPs in New York State, and

WHEREAS, the diversion of E9-1-1 funds results in a system that does not direct sufficient revenue to allow counties to properly maintain existing systems while also preparing to implement NG 9-1-1 technology required under federal law, and

WHEREAS, under current law, for the last four budget years, \$10 million was authorized and targeted directly to PSAPs and up to \$65 million was set aside for the provision of grants and reimbursements to counties administered by the State Interoperable Communications Grants (SICG) program, administered by the New York State Division of Homeland Security and Emergency Services (DHSES), and

WHEREAS, due to the designation of E9-1-1 fees for non 9-1-1 related expenses, New York State PSAPs are not eligible for any of the \$115 million in federal grant funding for E9-1-1 and NG 9-1-1 enhancements and IP-based advanced networks, and

WHEREAS, the goal of upgraded NG 9-1-1 systems is to make sure that all devices capable of connecting to the system can do so using voice, text, video images and other data formats to better inform the emergency responders of the situation they will be entering, and

WHEREAS, NG 9-1-1 upgraded systems will be able to better pinpoint an emergency call that may be in a remote area of the state or in a multi-storied building in one of our communities, and

- WHEREAS, recognizing a more precise location of those needing emergency services will improve outcomes and save lives, but this cannot be accomplished without consistent and timely funding from the State,
- **NOW, THEREFORE, BE IT RESOLVED** the Board of Legislators calls on New York State to sufficiently invest in 9-1-1 funding to ensure proper maintenance with existing systems and prepare for next generation 9-1-1 technologies, and
- **BE IT FURTHER RESOLVED** that the Board of Legislators further calls on DHSES to implement the draft 9-1-1 plan, and ensure the creation of a statewide NG 9-1-1 system connecting all of the county and municipal 9-1-1 systems into one statewide system, and
- **BE IT FURTHER RESOLVED** the Board of Legislators further calls on the State to fund NG 9-1-1 implementation with state resources, and
- **BE IT FURTHER RESOLVED** releasing these funding obligations on a regular schedule will provide certainty and build continuity as we upgrade and maintain existing systems and prepare for and implement NG 9-1-1, and
- **BE IT FURTHER RESOLVED** that certified copies of this resolution be forwarded to Governor Kathy Hochul; Senator Joseph Griffo; Senator Patricia Ritchie; Senator Dan Stec; Assemblyman Ken Blankenbush; Assemblyman Billy Jones; Assemblyman Robert Smullen; and Assemblyman Mark Walczyk.

DESIGNATING THE ST. LAWRENCE COUNTY CHAMBER OF COMMERCE AS THE ST. LAWRENCE COUNTY TOURISM PROMOTION AGENT

- **WHEREAS**, the St. Lawrence County Chamber of Commerce has represented the County as its Tourism Promotion Agent and this designation provides them with eligibility for I Love New York Funding, and
- WHEREAS, it is requested that counties appoint a Tourism Promotion Agency in order to participate in the Empire State Development Division of Tourism Matching Funds Program, and
- **WHEREAS**, participation in this program doubles the earmarked Tourism Promotion Funds by St. Lawrence County through I Love New York Funds, and
- WHEREAS, according to the NYS Tourism Economics Report (2021), visitor expenditure accounted for more than \$136.2 million in St. Lawrence County, and \$10.7 million in local taxes in 2021, and
- WHEREAS, according to the NYS Tourism Economics Report tourism spending has increased year to year, with a 33.8% increase between 2020 and 2021 and a 103.6% increase between 2019 and 2021, supporting the importance of investing in the continued growth of the tourism industry post-pandemic, and
- **WHEREAS**, according to the NYS Tourism Economics Report an estimated 1,486 jobs in the County (2021) were supported by visitors, and
- WHEREAS, the St. Lawrence County Chamber of Commerce represents the County as its Tourism Promotion Agent by creating a comprehensive marketing and advertising campaign, consisting of events, attractions, and recreational opportunities throughout the County, and
- WHEREAS, tourism marketing and the opportunity to leverage state grant opportunities operate in a two year cycle and require a digital marketing presence,
- **NOW, THEREFORE, BE IT RESOLVED** that the Board of Legislators designates the St. Lawrence County Chamber of Commerce as the St. Lawrence County Tourism Promotion Agent, and
- **BE IT FURTHER RESOLVED** that the 2023 is the last year of the current contract with the Chamber of Commerce which maintains the funding mechanism in a formula that incentivizes the Chamber to work diligently to improve tourism in St. Lawrence County, and
- **BE IT FURTHER RESOLVED** that the base formula will provide fifty (50%) of the occupancy tax revenue as an appropriation to the Chamber for 2023, and

BE IT FURTHER RESOLVED that the percentage of occupancy tax shall be based on a rolling five (5) year average and every dollar above the average will be shared at seventy-five percent (75%) to the Chamber of Commerce and twenty-five percent (25%) to St. Lawrence County, and

BE IT FURTHER RESOLVED that the County recommends that the Chamber of Commerce continue to improve its financial position and bring measurable successes to the Board of Legislators annually for review.

ACCEPTING THE RECOMMENDATIONS OF THE COUNTY ADMINISTRATOR REGARDING THE 2022 ANNUAL VACANCY REVIEW ANALYSIS INCLUDING RESCINDING RESOLUTION NO. 281-2008 AND AMENDING RESOLUTION NO. 304-2012

WHEREAS, the Vacancy Review Committee was reestablished in 2015 and has a membership consisting of two (2) Legislators (rotating each month), the County Administrator, Human Resources Director, Assistant Administrator, and Payroll Staff, and since that time vacancies have been presented to that committee with the Board of Legislators receiving recommendations on a monthly basis, and

WHEREAS, this has been a successful process and through recommendations of the Committee a number of strategies have been employed over the years to assist the County in filling and/or delaying the fill of positions, utilizing vacancies to appreciate savings, and only creating positions when others have been abolished, and

WHEREAS, annually, the County Administrator has been presenting an analysis to the Board of Legislators that captures the policy of the Board of Legislators has been fulfilled and alternatively presenting recommendations when a change in policy managing positions would be in the best interest of the County, and

WHEREAS, this year, as a part of the review there are six (6) recommendations made to the Board of Legislators as a result of reviewing the challenges in the ability to retain existing talented staff, fill positions, and recruiting talented staff in the future,

NOW, THEREFORE, BE IT RESOLVED that the Board of Legislators accepts the recommendations of the County Administrator regarding the 2022 Annual Vacancy Review Analysis and grants authorization for the following:

- Rescind Resolution No. 281-2008 this action would officially end the hiring freeze established in 2008;
- Amend Resolution No. 304-2012 to strike the last "Be It Further Resolved that any
 future salary increases will be applied to the schedule on an alternating percentage and
 lump sum basis." I would recommend this action be stricken and return to allow the
 provision of the percentage to be applied annually as authorized in Resolution No. 782000;
- Commission a Compensation Study to be prepared by an outside organization through an RFP/RFQ Process initiated by the County Administrator of County employees to include; Management/Confidential, CSEA, and all additional active titles;

- Negotiate with the Unions for a Memorandum of Agreement to improve the existing benefit known as 'vacation buy back' to increase access which would provide for employees to utilize this benefit without taking the mandatory required five (5) consecutive days off, instead include two requirements: (1) maintain a minimum balance of 100 hours, and (2) it must be taken in the increments that the employee works (35 or 40 hours), without a limit on annual access;
- Continue the practice and amend the 2021 recommendation of allowing temporary positions at the discretion of the County Administrator to assist with operational needs and allow part-time management/confidential staff to access benefits and prorated accruals;
- Continue the practice and amend the 2021 recommendation for planning for the transition in key roles that require a substantial training period that are allowed to overlap once notice of retirement/resignation has been officially provided, and allow the positions that are created for the purpose stated in the 2021 recommendation to have benefits and accruals upon original hire date, and

BE IT FURTHER RESOLVED that the recommendations be implemented upon adoption of this resolution and the adjustment to the benefit be implemented upon successful negotiation with the Unions impacted by this change.
