WHEREAS, as a result of this RSOI process the County selected the Development Authority of the North Country (DANC) as its sub-recipient for this community development program,

It was also discovered through criminal history use and dissemination audits, that the St. Lawrence County Sheriff's Office in not allowed to share fingerprint criminal history responses with other police agencies. Having one Detective assigned to the pistol permit process will help streamline the pistol permit process as well as allow the road patrol to focus on their tasks.

The revenue that is generated by the DMV is dependent upon having sufficient staff to process the local and down state dealer work. The projected revenue for 2024 was based on having a certain number of trained staff which included this position. If this position is not filled, the projected revenue for 2024 will be decreased substantially as more overtime will be required to complete the work required. This position is required to provide quick efficient service to the public and maintain down state revenue witin the expected turnaround time. Immediate fill is respectfully requested. It takes anywhere from 6 months to a year to train a staff member. It is imperative to be able to get that process started as soon as possible. Last year almost \$40 million dollars passed through our local DMV Offices. St. Lawrence County retained over \$3.5 million of that.  We have further been shorted staffed with two employees out on medical leave.
