AUTHORIZING THE CHAIR TO SIGN A CONTRACT WITH THE NEW YORK STATE DIVISION OF CRIMINAL JUSTICE SERVICES TO ACCEPT A FY21 ALTERNATIVE TO INCARCERATION, PRE-TRIAL, AND ELECTRONIC HOME MONITORING GRANT

WHEREAS, the New York State Division of Criminal Justice Services has renewed the Alternatives to Incarceration (ATI) Programs and Services, Pre-Trial, Electronic Home Monitoring Program Grant for a fourth year, with a contract period of January 1, 2021 through December 31, 2021, and

WHEREAS, the Grant will be used to employ a Probation Officer, pay the cost of two mobile devices, vendor equipment, and rental fees for jail inmates that are considered moderate to high risk who would otherwise not be eligible for pretrial release and would remain in jail while their case remains pending, and

WHEREAS, offenders could be released under supervision on either Electronic Home Monitoring or Alcohol Monitoring during any given month, and it is anticipated this could alleviate a portion of the burden placed on the County Correctional Facility, and

WHEREAS, inmates in need of community-based services, as referred by Probation or the Courts, could utilize the walk-in clinics for immediate evaluations and engagement in outpatient services, thus providing significant savings to the County and alleviating Addiction Services from completing evaluations at the County Correctional Facility,

NOW, THEREFORE, BE IT RESOLVED that the Board of Legislators authorizes the Chair to sign a contract with the New York State Division of Criminal Justice Services to accept a FY21 Alternative to Incarceration, Pre-Trial, and Electronic Home Monitoring Grant (Q1033105 56000 EM), upon approval of the County Attorney, and

WHEREAS, the Office of the Public Defender applied for and was awarded a total of \$300,000 over three years (July 1, 2021 through June 30, 2023) to provide continued funding for an Assistant Public Defender Position in the Office of the Public Defender to support the burgeoning caseload, and

WHEREAS, the continued efforts of the Public Defender and county staff to find new sources of revenue to support mandated efforts is as important as maintaining existing revenue sources that have now become competitive,

Preliminary Report Regarding Impending Evictions in St. Lawrence County, NY

The ongoing presence of COVID -19 has led to a deferral of on time rent payments to landlords, which is anticipated to have a devastating effect on housing in St. Lawrence County and across the country. The Justice and Law Center in Massena, which handles the majority of eviction cases in the County, reports that eviction applications filed by landlords have increased by 75% in the past year. In the past four months, as many as 260 eviction applications have been filed, for an average of four per day.

Evictions have been on hold, by a variety of authorities. The Centers for Disease Control halted evictions last year, on the basis that putting people out of housing units contributed to the spread of COVID-19. Subsequently, the Cares Act at the federal level, and Gov. Cuomo's Executive Orders at the state level, have each placed a moratorium on evictions when the tenant can demonstrate that COVID-19 had adversely affected their ability to pay rent.

And yet, eviction applications are piling up, at a rate of four per day; landlords have no other recourse when rent is not paid. When the current moratorium ends, now projected as April 30, 2021, those applications will begin to move through the judicial system, and hundreds of tenant households will be put out of their housing – while the pandemic continues.

Most landlords in the County are small-scale, owning one or several housing units. They may have some cash reserves, but in the face of an entire year of COVID-19 affected interruptions to their rental income, many of these small-scale landlords are facing the inability to make needed repairs to their units, or pay property taxes. And they cannot evict tenants that may truly need to be removed - those who damage their units, or who conduct illegal activities, for example.



Federal and State efforts to provide relief have been insufficient, both in scope and scale. As an example, one initiative from NYS HCR would have paid up to three months' rent for a tenant who could demonstrate an inability to pay rent due to COVID-19. However, by the time the program was announced many renters were more than three months late on rent; they would be left with the remaining arrearage, and possibly with a continuing inability to pay rent, due to continued unemployment. In addition, the two rounds of this program had very short application periods.

It is clear that the current stalemate in the housing market cannot continue, while eviction applications continue to pile up. In recognition of the difficulties faced by landlords, the Board of Legislators approved a resolution at their February 2021 meeting, calling upon the State of New York to provide relief to individual investors of rental properties impacted by reduced rent collections due to the COVID-19 pandemic.

The Fair Housing Task Force is especially concerned that the current COVID-19 related stalemate in the rental housing market might spiral into a new cycle of disinvestment in the low- to moderate-cost portion of the housing market. The progress represented by these years of investment by the County and private lenders may be undone by a failure to recognize and to act on the problems that are being faced each day by landlords and tenants.

The health of the housing market in the County is at stake. The Fair Housing Task Force respectfully asks the Board include the impending evictions crisis as a legislative issue agenda item, and to insist State and Federally elected officials develop emergency assistance to make landlords and tenants whole. The Task Force recommends communicating to that late rental payments have created a cascading effect on deferred housing maintenance by property owners, and that tenants who are behind on rent are facing impending evictions. There is also serious concern that landlords may file for bankruptcy, and will likely become delinquent on payment of real property taxes.

In the interim, there are a few agencies that may be able to assist area landlords and tenants:

- 1. The St. Lawrence County Community Development Program can offer **emergency rental and utility assistance** through its Neighborhood Centers to anyone who financially qualifies. Current qualifications are 200% of federal poverty level. Persons seeking assistance should contact their nearest Neighborhood Center. - 2. Maximizing Independent Living Choices' Solutions to End Homelessness Program (STEHP) assists households who are at-risk of becoming homeless and helps participants transition to housing stability.
