PROCLAIMING JUNE 27, 2021 AS NATIONAL HIV TESTING DAY IN ST. LAWRENCE COUNTY

- WHEREAS, National HIV Testing Day (NHTD) is observed annually on June 27th, and on this day partners, health departments, and other organizations unite to raise awareness about the importance of HIV testing and early diagnosis of HIV, and
- **WHEREAS**, the 2021 NHTD theme is "My Test, My Way" which highlights how you can take charge of your health by getting tested in a way that works best for you, and
- WHEREAS, a key component in the fight to stop HIV is to connect with people most at risk and provide testing, treatment, and prevention education as these are keys to healthy communities, and
- WHEREAS, in the 30 years since the Centers for Disease Control and Prevention (CDC) first reported on a new disease that would eventually be known as HIV/AIDS, nearly 600,000 Americans have died from AIDS, and thousands more live with disabilities due to symptoms and complications of the disease, and
- WHEREAS, today advances in medical care and antiretroviral therapy (ART) have decreased the number of people with HIV who get AIDs, but still 1.2 million people are living with HIV in the United States and 16,000 Americans with AIDS die each year, and
- WHEREAS, confidential and anonymous HIV testing clinics are held weekly at the St. Lawrence County Public Health Department at no cost for this service for St. Lawrence County residents, and
- WHEREAS, with a focus on public health, St. Lawrence County encourages its citizens to know their status by getting tested and seeking medical intervention if needed, and
- WHEREAS, St. Lawrence County would like to end negative attitudes and beliefs about people diagnosed with HIV, and encourages all people to commit to making positive changes of support for friends, family, and neighbors living with HIV thereby making it easier for them to live healthy lives, and to work as a community to break the HIV stigma,
- **NOW, THEREFORE, BE IT RESOLVED** the Board of Legislators proclaims June 27, 2021 as National HIV Testing Day in St. Lawrence County, and
- **BE IT FURTHER RESOLVED** that the 2021 NHTD theme is "My Test, My Way", and encourages all citizens to know their status by getting tested.
