### AUTHORIZING ADDITIONAL CORRECTION OFFICER POSITIONS IN THE ST. LAWRENCE COUNTY CORRECTIONAL FACILITY

By Mr. Acres, District 8

WHEREAS, the New York State Commission of Corrections mandates staffing for correctional facilities and has identified fifty-six (56) officers as the minimum for the St. Lawrence County Correctional Facility, and

WHEREAS, the current make up of available staff to schedule is at a critical level which has required scheduling adjustments among other strategies to ensure all shifts are adequately staffed to ensure inmate and officer safety, and

WHEREAS, since the facility opened in 2009, the County has been able to function adequately with fifty-six (56) officers, and part-time correction officers to model this is no longer feasible, and

WHEREAS, upon recommendation of the Sheriff and County Administrator, an increase in full-time Correction Officers is warranted with five (5) vacant part-time Correction Officer being abolished to assist in absorbing the cost of additional full time positions, and these positions will be reviewed annually,

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Legislators authorizes filling the following vacancies:
