There will be a Drug Awareness training seminar on April 21st at SUNY Canton at 17:30.

There was discussion on what to do about Newton Falls Fire.

The State Police are not leaving the dispatch center as of now in 2015, more to come on this.

**Training:** We have a FF1 class now, 24 signed up and there is 22 still in it. The Training center is booked thru fall, if anyone wants to schedule it please contact Bob White.

Joe Gallagher, the committee has met and gave a report, there is a handout and the changes to be made were discussed and to be voted on at the next meeting.

Mutual Aid Plan: Kevin Crosby gave a report on this, handout with updates was went thru and changes to be made with some wording. This will be brought back to the next meeting for approval.
