1900 hrs: Meeting Called to Oder by Chairman Finnegan. Secretary's report offered for discussion. Nothing further of the report M/M Rick Rusaw to accept, 2<sup>nd</sup> by Larry Denesha, Carried.

Floor turn over to Larry Denesha for legislative update. Larry gave update on latest Covid numbers. Larry stated the county was using 2 million dollars of ARPA funds for IDA projects related to workforce development, infrastructure, childcare, small business and not for profits. Review of Fire, EMS, L/E calls dispatched for July Fire-454, EMS-2036, Local PD-367, NYSP-378, Sheriff 1,089, Information Calls- 1,267 July Total 5,591. Year to date totals 34,554

Communications project- RFP sent out, 3 bids received.

Reviews to be conducted before awarding. 5 million ARPA funds will be used for project. Need to brief legislature and hope to move forward by February 2023.

<u>University games</u>: Not much impact on fire departments, EMS as needed, lots of spectators in county. Potsdam State using dorms. Bloomingdale NY holding a bus rescue class. State also offering Crowd Control Management Training.

Per instructors, the Brier Hill BEFO class was not good. Having it at the station was not the best environment for learning.

Mutual Aid plan was discussed. Issues with Newton Falls not holding up their end of the county mutual aid plan. Leaving the scene of fires that are in their area of responsibility to other mutual aid departments. Newton Falls chiefs and board of fire commissioners are not willing to sit down and discuss the plan. It was suggested legal advice maybe needed or possible contact the state comptroller office for help.
