This program supports opportunities for public engagement with the arts and arts education, for the integration of the arts with strategies promoting the health and well-being of people and communities, and for the improvement of overall capacity and capabilities within the arts sector. A variety of organizations are eligible including those serving rural, urban, suburban, and tribal communities of all sizes; and from organizations with small, medium, or large operating budgets. Grants range from \$10,000 to \$100,000. All grants require a nonfederal cost share or match of at least 1 to 1. In addition, designated local arts agencies eligible to subgrant may request cost share/matching grants ranging from \$30,000 to \$150,000 for subgranting programs in the Local Arts Agencies discipline.

Deadline: This program has a two-part application process; the Application for Federal Domestic Assistance/Short Organization Form is due July 11, 2024, then the NEA Applicant Portal is open from July 16 to 23, 2024.
